It is preferred and necessary for the logo versions be used for specific types of media and best reproduction. EXAMPLES BELOW:

- .eps = used for printing high quality images, ie. vector image without loss of quality
- g = can be high or low resolution and used for video/web. This will have a white background behind it.
- .png = can be high or low resolution and used for video/web. This image will have a transparent background.
- pdf = used for print files. This can be saved high or low resolution. Print quality is 300dpi at 100% of the size you wish to print the logo. Low resolution is 72dpi. This is a second choice to the .eps file if one is not given.


